I want to start by letting you know that I have no ulterior motive and make no money from my efforts to educate the community. To the contrary, I am volunteering my time to try to save your life and the lives of your loved ones.

It is very important for me to make clear that I am NOT against safe vaccines. The Covid "vaccine" is NOT a vaccine, but a novel genetic therapy being used on humans for the first time without having gone through sufficient animal safety trials or long-term human trials. It's CALLED a "vaccine" to make you think it's safe, because you know vaccines are safe.

Yes, you will definitely hear otherwise, but stay with me while I show you that the facts are being knowingly twisted. For example, old studies that showed inherent dangers of any coronavirus vaccine (because of the near-certain risk of long-term cytokine storm and death by ADE) are being "updated" and the damning evidence from the animal trials removed.

Physicians pushing the vaccine are telling people who already had the virus to take the shot anyway, even though their risk of adverse reactions is much higher. They are IGNORING THE MEDICAL SCIENCE which proves that while ANTIBODIES wane, they do not fully disappear. The cells producing them actually hide in the bone marrow and remain ready to churn out more antibodies if needed. PLUS, ANOTHER KIND of protective cells, called T-cells, offer LIFETIME IMMUNITY. Scientists and doctors risking their careers by speaking about the dangers of the covid vaccine are being quickly taken down, sometimes within hours. This happened to us when we produced a video of physicians speaking out about the dangers of the shot. Facebook groups of adverse reactions and even google docs are being removed from the internet.

There are BILLIONS of dollars being poured into advertising and pushing the vaccine by the government and media – and even by local health organizations who are being paid by the government to promote it. All this, while scientific and medical voices to the contrary are systematically suppressed. Meanwhile, the vaccine companies will earn tens of billions of dollars from the vaccine sales – and they're just warming up because the plan is to require booster shots every 6 months, in addition to yearly vaccines. Manufacturers have been given a GUARANTEE OF ZERO LIABILITY by the government (thanks to the PREP Act and National Childhood Vaccine Injury Act of 1986), so they have nothing to fear. No matter WHAT HAPPENS TO YOU AFTER THE SHOT, G-D FORBID, you CANNOT sue them.

HAS ANYTHING LIKE THIS EVER HAPPENED BEFORE IN MEDICAL HISTORY? Has a NEW therapy ever been pushed through without proper safety trials while deaths mount (currently standing at over 5,000 deaths reported to VAERS in the U.S., and over 12,000 deaths reported in the E.U.) – and the CDC pretends everything is fine, pushing the shot on pregnant women and children as young as 12 under EUA (Emergency Use Authorization), with plans to give it to younger ones very soon as well? No, it has NEVER happened before.

The last time that a vaccine was given EUA was during the Swine Flu Epidemic in 1976, and when that vaccine caused multiple cases of Guillain Barre Syndrome and killed 25 people, it was pulled off the market.

HAVE PEOPLE EVER BEEN SO BLIND and gullible? Parents, pregnant women, teens, and people who already recovered from coronavirus line up to be shot with complete faith. Have such horrible lies ever been told

before in the medical world – that children should be worried about the long-term effects of Covid (and of being responsible for the death of their grandparents if they don't get the "vaccine"), but NOT be worried about an mRNA technology never used on them (or on their parents) before?

WHY does the lie continue to be told that children are not only in danger from the virus themselves, but are also dangerous "spreaders," who must be inoculated for the safety of the world, while in reality facts on the ground show that neither statement is true, and children actually have a PROTECTIVE EFFECT ON THE ADULTS IN THEIR HOUSEHOLD? For example, studies in various school districts showed no transmission child-to-child NOR CHILD-TO-ADULT. (See end of this booklet for citation of some of those studies, and others.) EVEN IF YOU INSIST on believing the LIE that children are spreaders of any significance, since when does a parent risk their child's health and future to protect others?

The lies that that have been told about the early at-home treatments have likely killed 500,000 people, as HCQ and then ivermectin have been suppressed, vilified, and mocked...but the true studies show that they DO work, and very well at that (as I, a volunteer who steers patients to proper treatment, and as thousands of doctors worldwide can attest). In the following article, you will get all the proof that you need, as Dr. Pierre Kory attests to the efficacy of ivermectin in preventing corona and treating it at all ~~times~~ <sup>ages</sup>. That there have been a total of 56 trials involving 469 scientists and 18,447 patients, and 28 of these were the "gold standard" RCT trials. WHY is the government murdering people by withholding treatment while at the same time hyping fear by creating a Covid death count that's determined DIFFERENTLY than ever before (anyone with a positive Covid test in the last 28 days is a Covid death, regardless of comorbidities or other real causes).

And WHY are the numbers of cases of covid infection in vaccinated people no longer being reported to us by the CDC, unless the patients are hospitalized or die? Surely, people will be convinced that the vaccine is "working," as the cases in the vaccinated will magically disappear. On April 16, the amount of "breakthrough" cases in fully vaccinated people was 9,245, including 132 deaths, but the CDC isn't giving me any new numbers now.

WHY do death rates spike after a few weeks in almost every country WORLDWIDE that sees a Covid vaccine rollout (INCLUDING ISRAEL!) but the public is lied to about what is actually happening, endless "variants" are blamed, and more vaccination is prescribed?

YES, you read that correctly. Israel is NOT the vaccine success story that it is touted to be. The virus was already declining there BEFORE the vaccine was rolled out (look up Farr's Law). When vaccination started, cases and deaths spiked, and the months following the vaccine rollout were the deadliest in the history of the country, including for young people. YOU OWE IT TO YOURSELF AND YOUR FAMILY TO RESEARCH THIS THOROUGHLY. Your family doctor is likely well-meaning but does NOT have a strong background in immunology and molecular biology. He says the "vaccine" is safe because that's what the CDC, AAP, etc., say – but the CDC has their own agenda, not the least of which is profit (yes, Dr. Fauci and many others at the CDC and FDA hold patents and EARN ROYALTIES ON SALES OF VACCINES AND OTHER PHARMACEUTICALS).

You will find more than 80 pages of fascinating information, meticulously sourced, that will hopefully answer all your questions. In case you just want a quick summary, here are some of the most important facts. In the interest of space, I only included a partial list of sources to support the statements made here, but you can find the rest in the book.

## JUST WHAT IS SO DANGEROUS ABOUT THE "VACCINE"?

- 1) The possibility of severe allergic reaction, anaphylaxis, and immediate death, due to the PEG (polyethylene glycol) in the injection.
- 2) The spike protein that the vaccine induces the body to produce causes heart damage, inflames lung tissue, and causes vascular issues such as strokes and blood clots. Research shows that it is the spike protein itself that causes the problems associated with corona – and now we are programming people's bodies to MAKE that deadly spike protein! New research from Harvard shows that the spike protein does NOT remain in the cells as claimed, but rather can be detected in the bloodstream as soon as ONE day after the vaccine. See articles further on.

- 3) RUINING OUR IMMUNE SYSTEM: According to Geert Vanden Bossche, top vaccine developer, the massive quantity of highly specific antibodies, which the body is induced by the vaccine to make against a single strain of coronavirus, will crowd out and dominate our natural antibodies that are NOT specific and can fight ANY pathogens. *Thus, we are immobilizing our immune system's response to other viruses and diseases.*
- 5) THE BODY ATTACKING ITSELF: The body's production of the spike protein is likely to outlast its production of antibodies. When the antibodies are unable to completely rid the body of spike proteins, the immune system will call up killer cells (T- cells) to kill the cells that are producing the spike proteins. This is because, in a well-functioning immune system, the body is programmed to destroy any cells that are not natural to the body as a protection against cancer. Since EVERY cell in the person's body has the ability to produce the spike protein, this can be DEADLY. *The body will begin attacking its own cells, causing autoimmune diseases, organ failure, and other devastating results. THIS IS A LONG-TERM EFFECT THAT WILL NOT BE SEEN IMMEDIATELY.*
- 6) THE mRNA CARRIES HUGE UNKNOWN RISKS for altering the DNA and chromosomes. What that will mean for future generations, only time will tell. It was previously believed that RNA moved in only one direction, in that the DNA delivers the code to the RNA, which in turn tells the cells what to do. We now know that this is outdated science, and it's actually a TWO-WAY street. *The RNA can also alter the DNA as well as the chromosomes. Playing G-d by altering the DNA of humanity is mind-boggling.*
- 7) ANY CORONAVIRUS VACCINE CARRIES THE HIGH, LONG-TERM RISK OF ANTIBODY-DEPENDENT ENHANCEMENT (ADE), which causes the immune system to overreact and can lead to death. In animal trials for previous coronavirus vaccines, almost all the animals died of cytokine storm caused by ADE upon release and exposure to the wild virus (*not immediately*). Those vaccines never made it to market for this exact reason.

By the way, ALL the vaccine companies have faced lawsuits or huge fines for fraud and dangerous products. For example, in 2009 Pfizer was sued, and had to pay, \$2,300,000,000 for fraud and bribing doctors in their drug marketing.

And guess who ran Pfizer's Covid vaccine trial? Not the FDA. Three Pfizer employees, all by themselves!

So, what adverse effects are being seen from the shots? SO, SO MANY that it's mind-blowing. Let's look at the early-warning system that the U.S. government set up in 1990 to serve as a "red flag" for problems with vaccines. It's called the Vaccine Adverse Events Reporting System, or VAERS.

We can get a good comparison of the results of the genetic Covid injection with regular vaccines by going into the VAERS database. In 2019, the last "normal" year, VAERS received 43,488 reports of adverse events for the WHOLE YEAR for ALL vaccines combined. That was typical. But as of April 30, IN JUST THE FIRST 4 MONTHS OF 2021 SINCE THE COVID SHOT ROLLOUT, they received 156,984 reports of adverse events for JUST THE COVID "VACCINES"! Projecting to the rest of the year by multiplying by 3, that's a forecast of 470,000 adverse events for ONE SHOT – MORE THAN TEN TIMES THE TYPICAL AMOUNT IN A YEAR for ALL vaccines COMBINED! (Now as of May 28, it's up to 294,801.)

HOSPITALIZATIONS following ALL vaccines in 2019 were 2,827, but JUST for the four months of the Covid vaccine alone they were 10,715. (Now, as of May 28, the number is up to 17,619.)

DEATHS for all other vaccines combined were 196 for the year 2019, but a whopping 3,827 for 4 months of the Covid vaccine alone. That was as of April 30, and the number of deaths has since grown to 5,165 as of May ) THIS NUMBER EXCEEDS THE TOTAL NUMBER OF DEATHS REPORTED TO VAERS FOLLOWING ALL 70 VACCINES IN THE LAST 30 YEARS COMBINED!

IF THIS IS NOT A "RED FLAG" ON AN "EARLY WARNING SYSTEM," THEN WHAT IS?

G-D help us! How do people have the gall to lie to us and claim that there is "no downside" to the shot?

Here are some specifics. As of May 28, following less than 6 months of use of the Covid vaccines in the U.S., there have been reported to VAERS:

- 39,078 ER visits, 17,619 hospitalizations, and 797 patients in ICU
- 1,350 cases of facial paralysis
- 1,473 strokes
- 1,481 cases of pulmonary embolism (blood clot in lung)
- 561 cases of cardiac arrest
- 675 cases of oxygen saturation decreased
- 987 cases of deep vein thrombosis
- 159 cases of kidney failure and 475 of acute kidney injury

- 6,608 cases of tremor
- 2,830 cases of blurred vision, 1,498 of vision impairment, 174 of eye hemorrhage, and 410 cases of blindness
- 2,645 cases of gait disturbance and 1,462 cases of balance disorder
- 676 cases of speech disorder
- 498 cases of memory impairment and 468 cases of hallucination
- 559 cases of deafness
- 370 people required resuscitation and 433 required intubation

For statistics from the worldwide W.H.O database, \_\_\_\_\_ and put in Comirnaty (Pfizer's European brand name) to see a breakdown of 975,559 adverse events reported from this vaccine. Interestingly, these should NOT REALLY COME AS SUCH A SURPRISE, as the FDA did publish a list all the way back in December 2020 of 22 possible side effects of the vaccine, many of them deadly.

We know that these numbers are really way lower than the reality because we hear numerous reports of doctors REFUSING to make a VAERS REPORT, CLAIMING THAT A STROKE OR HEART ATTACK A FEW DAYS AFTER THE VACCINE "WAS UNRELATED TO THE SHOT," and because studies have shown that typically only 1% -10% of vaccine adverse reactions get reported.

Medical Experts Raise Alarm Over Safety of COVID-19 Vaccines in Children, Pregnant Women, and Those Who Already Have Antibodies By [Debra Heine](http://Debra Heine) May 21, 2021

Two prominent medical professionals (Dr. Peter McCullough and Dr. Harvey Risch) are raising red flags over the safety and efficacy of the COVID-19 vaccines in children, in pregnant women, and in those who have previously caught the coronavirus and now have antibodies.

There are alarming reports in the Centers for Disease Control and Prevention's Vaccine Adverse Event Reporting System (VAERS) of healthy children dying shortly after being vaccinated, the doctors say. Also, multiple studies are showing higher rates of adverse effects in people who have recovered from the virus, and the vaccine is not proven to be safe for pregnant women, especially those in their first trimester, according to the doctors.

Dr. Peter McCullough, an American professor of epidemiology at Baylor University, and Dr. Harvey Risch, professor at the Yale School of Public Health, recently appeared on Fox News' "Ingraham Angle" to voice their concerns regarding these issues. McCullough told host Laura Ingraham that randomized vaccine trials excluded individuals with COVID-19 antibodies, so we don't know if the vaccine is safe for those people. McCullough also pointed out that there have been no studies demonstrating the clinical benefit of vaccinating these people. "Now two studies out of the United Kingdom and one out of New York City show higher rates of vaccine-adverse events when COVID-19 recovered patients are needlessly vaccinated," the doctor said. Because of this, McCullough told Ingraham, it is "contraindicated" for these patients to receive the vaccine. "No evidence of benefit, and only evidence of harm," he explained. Additionally, researchers have just released alarming findings from a study involving 13 participants who received two doses of mRNA-1273 vaccine. The Harvard study found that the vaccine's spike proteins may enter the bloodstream of an individual after their T-cells—the white blood cells that fight off infections in healthy immune systems—destroy the cells that contain them. *The spike protein is what gives the coronavirus family of viruses their name. The spikes jut out from the surface of the spherical virus, giving it a crown-like halo, hence "corona."* Researchers have also known for a long time that the spike protein is the business end of these viruses; it is what gives the virus its ability to target, latch onto, and enter the cells that it infects. Mutations in the spike protein are also what determine different variants of SARS-CoV-2, and can alter its ability to infect and cause harm. The spike proteins produced by the vaccines were said to be of no threat to the vaccinated individual because they weren't supposed to leave the cells that make them. According to the Harvard researchers, "11 of 13 participants showed detectable levels of SARS-CoV-2 protein as early as day one after first vaccine injection." They concluded: "The clinical relevance of this finding is unknown and should be further explored."

Hey, remember how all the smart people told you the vaccines were super-duper safe because those spike proteins they make would never actually leave the cells that make them? Turns out that's...less than entirely accurate.

Anthony Fauci, the director of the U.S. National Institute of Allergy and Infectious Diseases and Biden's chief medical advisor, is now recommending that children as young as 4-years-old receive the experimental COVID-19 vaccines, and has set a goal to start vaccinating the youths by the end of the year. Ingraham asked Risch if it was irresponsible to push an experimental vaccine on kids. The doctor said that it was "irrational" because young children do not get particularly sick with the COVID and don't spread the virus, "so neither they, nor the society around them, have an interest in vaccinating them." Risch said that there are concerning reports in the VAERS database of youths dying shortly after receiving the jab. "Now we've started to see in the VAERS database 15-year-old children getting heart attacks, two-year-olds dying a day after the vaccination, a six month-old dying from her mother's vaccination through breastmilk," he said. "So children have no reason to die from vaccination."

Risch said in an interview last month, that the majority of people now coming down with the coronavirus are those who have been vaccinated against it. "Clinicians have been telling me that more than half of the new COVID cases that they're treating are people who have been vaccinated," he said on Steve Bannon's "War Room" program. "They've estimated that more than 60 percent of the new cases that they are treating—COVID cases—have been people who have been vaccinated," Risch said in April.

McCullough recommended that the CDC set up two standard committees to investigate whether the vaccines are doing more harm than good. "Now we're seeing really alarming rates of harm in the adverse event reporting system, so the CDC really immediately needs to have an external, unbiased, event adjudication committee and data safety monitoring committee as it would in any clinical investigation," he said. It's doubtful, however, that the CDC will take that action. Instead, CDC Director Rochelle Walensky has recommended that pregnant women get the jab, even though pregnant women were not studied in the clinical trials for the vaccines. "We haven't even studied long enough to know the outcomes from first trimester vaccinations," Risch said. "We don't know what happens to their offspring." Risch explained that there are risks of stillbirths and genetic defects if a woman has a fever in the first three months of pregnancy. Fever is a common side effect people experience after they've been vaccinated.

Both doctors were early advocates for the use of hydroxychloroquine as a treatment for the coronavirus. Thousands of lives—perhaps as many as 100,000—could have been saved if certain research had not been suppressed and treatments like hydroxychloroquine and Ivermectin had been made available to patients, according to a new report. "In a recent working paper analyzing the determinants of COVID-19 fatalities, the authors—Michigan State University economics professor Mark Skidmore and co-author Hideki Toya—estimated "if the U.S. had made [hydroxychloroquine] widely available early on, 80,000 to 100,000 lives could have been saved," lamented Dr. Pierre Kory, a critical care specialist at the University of Wisconsin.

President Trump famously touted the promising treatment during a press conference last May, and encouraged its use to treat the coronavirus. Instead, the medical establishment, and the corporate media did everything it could to suppress the use of the safe, effective, and inexpensive treatment for COVID-19.

Pediatric rheumatologist J. Patrick Whelan had warned a vaccine advisory committee of the Food and Drug Administration of the potential for the spike protein in COVID vaccines to cause microvascular damage causing damage to the liver, heart, and brain in "ways that were not assessed in the safety trials."

While Whelan did not dispute the value of a coronavirus vaccine that worked to stop transmission of the disease (which no COVID vaccine in circulation has been demonstrated to do), he said, "It would be vastly worse if hundreds of millions of people were to suffer long-lasting or even permanent damage to their brain or heart microvasculature as a result of failing to appreciate in the short-term an unintended effect of full-length spike protein-based vaccines on other organs."

Below are some of the personal stories I have collected. I have NOT included most of the numerous and horrible stories relating to pregnancy, fertility, and menstrual cycles due to space constraints, but they can be viewed at the full document link cited above. CHILDREN'S STORIES AT THE END!

-I have received reports of FOUR people in the religious Jewish community who became paralyzed from the waist down after the corona vaccine.

-I just received a story of a 30 year old man who became blind after vaccination.

-I spoke on June 6 to a longtime Hatzalah member in Israel to corroborate the messages I had seen in his name. He testified to the following: Two men had severe strokes right after their vaccine – one who was in

the ICU for two weeks, the other a young person in his 50s who became paralyzed. Two men started having severe stomach pains after the shot, described as feeling like knives cutting the stomach, to the point of being unable to eat and having to hold a pillow over the mouth to keep from screaming. One of these men also had chest pains and went to the ER. The doctor, whom he was acquainted with, told him, "We are not allowed to say that anything is from the vaccine."

He mentioned that other people have ringing in their ears and migraines since their vaccine. The worst of all is what a nurse told him – that they get tens of patients a day, about a hundred a week, coming into the hospital with autoimmune problems (this means the body attacking itself, and was an adverse reaction to the shot that scientists warned about in advance).

-This correlates with a video that I received of a television interview in Israel, dated April 21, in which Professor Dr. Michael Dersher, who is in a senior position at Beilinson Hospital, states that the emergency situation in the hospitals in Israel is one never seen before, worse than during the height of the "third wave." Professor Dersher says that the large hospitals are seeing 500 patients coming in to the emergency room per day, while the middle-sized hospitals are getting 300-400 daily. STRANGELY, HE DOES NOT SAY WHAT THEY ARE COMING IN FOR. When the interviewer asks him what can be done to avoid catastrophe, he answers cryptically that the public must get the attention of the decision makers in the government. To anyone familiar with the terrible pressure the government has placed on the citizenry to vaccinate, and on the medical providers to ensure compliance, it is obvious that the professor is afraid to speak freely but is hinting at terrible numbers of vaccine adverse effects being seen, and is begging the public to rise up and call out the government policy. Taken together with the Hatzalah member testimony which I described above, it presents a compelling and horrifying picture.

Also about myocarditis in young people after vaccination. Please realize that as horrible as this article is, it represents only a "drop in the bucket" of the full picture of vaccine reactions that have occurred in Israel.

I also spoke to a gastroenterologist in NY, who has seen many people coming in with terrible flare-ups of digestive problems post-vaccine. Examples include nausea, abdominal pain, worsening IBD, ulcerative colitis flare-up, and even a NEW case of a small bowel obstruction from Crohn's, in a person who never had Crohn's before. The GI felt that it was important to note that the patients are NOT making the connection between their problems and the vaccine that they had just received, so they have NOT been reporting these adverse events, and neither is she, for lack of time.

- Y. reported: "One of my mechutanim had a healthy and vibrant father who was in his 80's. He was a retired chazzan and sang beautifully at my son's sheva brachos...my mechutan begged his father NOT to get the shot, but he chose to listen to his doctor instead. He developed severe headaches and finally went to the hospital, where he was found to have blood clots in his brain. He was niftar on April 29."

-N. reported about a friend's relative who has allergies, but got the vaccine anyway. She had an anaphylactic reaction and was hospitalized for a week. Unfortunately, she's now back in the hospital because of uncontrollable shaking.

-M. reported that her uncle got the shot and passed away the next day.

-A Rav noticed someone saying kaddish and started a conversation with him. It turned out that TWO of his relatives had passed away at almost the same time, EACH ONE HAVING A HEART ATTACK ON THE NIGHT AFTER RECEIVING THE SHOT. (He had not connected the dots until it was pointed out to him. This explains a lot about why nobody realizes what is going on. When you're convinced a product is safe, you aren't even thinking along those lines.)

-B. reported how a new customer entered an establishment and was asked "What happened to your old supplier?" Turns out he had been vaccinated and then had a stroke.

-A woman was seen healthy, vibrant at a chasuna, and right afterwards she received the vaccine and had a heart attack the next day.

-A 70-year-old man received the vaccine and has been deteriorating by the day since then, Hashem should help him, with shaking symptoms that appear like Parkinson's.

-A man who had health problems (nothing deadly, though) took the vaccine and passed away out of the blue 2 weeks later.

-A woman who had some health issues was vaccinated and then had a seizure, and is now in a coma. (Time and again, we see that when people have pre-existing conditions, they are more likely to have immediate ill effects from the vaccine.)

-My friend told me that her friend's husband got the first shot and had a stroke within days, while another older man we recently heard about also got one dose and suffered a stroke.

-Recently, my son-in-law heard about a 95-year-old man (he knows which shul he davened in) who had done well during corona but whose family decided to give him the vaccine. Soon afterward, he became weak and then passed away.

-A man with stable liver disease received the first dose and took a turn for the worse. He developed pneumonia and became incoherent, and passed away within several days.

-Rabbi S., a heart patient, was convinced by his doctors to take the vaccine. After the first shot, he felt unwell, tested negative for Covid, and was subsequently pressured to take the second shot. He became extremely sick after the second dose and was eventually put on a respirator. I hope he is better now.

-My friend was told firsthand about a healthy older man who got the vaccine, and suddenly, two months later, had a clogged artery and needed a stent placed, when he'd never had these problems before. He has another clogged artery since then, and he still isn't feeling well. My friend is hearing other similar stories as well.

-Right after reading my friend's message, I opened a link and saw that the very same thing is happening in India, with their vaccine also causing blocked arteries. A famous comedian named Vivekh, who was also the health ambassador in Tamil Nadu, just died at 59 years old. He had pushed for others to get the vaccine, and his vaccination was filmed publicly and aired on television. He was brought in unconscious the day after his injection, with 100% blockage of a blood vessel, and underwent a coronary angiogram and angioplasty. He was placed on ECMO life support and passed

away early the next morning of cardiac arrest. The government denies that his death has any correlation to his vaccine – but there are many similar cases happening there among people who were also vaccinated.

-A man called me with the story of his grandmother, who is 80 years old, and was told by the doctors how **important** it was for her to get the vaccine due to her preexisting conditions (in actuality, the preexisting conditions are more likely to increase the chance of vaccine adverse events). She got both doses of Moderna and 10 days later had a right aortic heart attack. She had a stent put in for her clogged artery, but instead of feeling better, she is just feeling worse and worse as time passes and the doctors are still trying to figure out what is wrong.

-A man told us that his father-in-law passed away after his second dose of the vaccine.

-A 65-year-old man took the J and J vaccine and now is in major pain all over his body. He developed Bell's Palsy, has visited the emergency room twice, and the kidney numbers on his bloodwork are now elevated, which the doctor says is from all the Advil he's taking to try and control his pain. Prior to the shot, his only issue was high blood pressure. Still, the doctor refuses to acknowledge that his disabling new health issues arose from the vaccine!

-An elderly man who had a medical history received the first shot and got very sick. He became incoherent and required dialysis and a feeding tube. After a few weeks, he had a massive heart attack and passed away.

-S.E. reported that she was in the park recently, and a woman there told her about a lady she knew in her 70's, in California, who was full of life. She had her second dose recently and passed away shortly afterward.

-An elderly man took the vaccine and now has a blood clot on his lungs and can't walk. His daughter-in-law believes that it's a direct result of the shot he received.

-An elderly Jewish woman, who was healthy except for some memory loss, took the vaccine. Days later she was rushed to the hospital for internal bleeding, which resulted in paralysis on half her body.

-A man in his 60's in Israel who took the vaccine about a month ago is constantly extremely tired and spends most of his day in bed sleeping now.

-A mostly healthy, active, and independent senior had an injury and had to go to the hospital. From the hospital, the senior was sent to rehab, and at the rehab center was given the vaccine WITHOUT FAMILY BEING CONSULTED. The senior became ill very quickly afterward with corona, despite the fact that the facility was on lockdown, and was sent back to the hospital and tragically passed away.

-My friend recently attended the funeral of an amazing woman who was so full of life. She was forced by her retirement home to take the vaccine, or leave. She took the shot and passed away.

-We just received the following heartbreaking and mind-blowing report from the acquaintance of the patient's friend: "Over Shabbos I went to visit a friend. He got the second vaccine, and had terrible migraines, followed by what appeared to be a stroke. He couldn't speak and was rushed to the ER, where he was treated as a stroke patient. He got his PhD two months ago, and now it takes him time and effort to speak. He's a father of two, in his forties. He can't drive or walk without someone with him. I asked him if he thought that it was a reaction to the vaccine. Absolutely, yes, he said, as the timeline was obvious. Then I asked if his opinion had changed about the Covid vaccine. No, he said. 'We believe in the science of it, and my wife just got her second dose.'"

-S.M., a healthy and active frum man about 82 years of age, resided in a senior assisted living place, as his wife had passed away. He wanted to be able to go out to shuirim, etc., as before corona, and was told that to do so, he would need to take the vaccine. He got the shot and was niftar the next day from a heart attack.

Reports from all over the world confirm that NUMEROUS previously healthy people, even young ones, suddenly pass away from heart attacks or other causes directly after the vaccine. Look at this site for documented stories with photographs (may not be suitable for men):

A woman I know related to me the following, which she personally knows factually: \*At Mt. Sinai hospital in Brooklyn, a nurse took the vaccine and a few days later dropped dead while walking in the hallway in the hospital. \*A doctor who took the vaccine lost his ability to swallow for a week afterward. \*A 39-year-old mother had an aneurysm while taking a shower and passed away, a few days after the vaccine.

-The Chabad shliach in Vineland, NJ, Rabbi Yisroel Rapoport, was niftar on February 4. In the voice note that Rabbi Rapoport's niece recorded, she states that her uncle had pre-existing health conditions, including diabetes, and was pressured to take the vaccine. Rabbi Rapoport felt unwell and began shaking after the first vaccine, but was still pressed to take the second one. Within two days he was shaking uncontrollably. His friend drove him to the ER where he passed away from a massive heart attack.

-I received a message from a woman on March 1, who reached out to me with the tragic story of her husband's very good friend, a healthy 70-year-old man in Brooklyn who was niftar in his sleep the Shabbos before. She stated: "He was perfectly healthy...had gotten corona in the summer and didn't even know it...why did he take the vaccine? He passed away Shabbos morning, didn't wake up...he had no health issues. It's literally devastating. Vaccine was about 2 weeks ago. My husband got together with him last week. He was totally fine. He had some reactions to the vaccine...both times...why in the world was he encouraged to take this shot? He had antibodies...just celebrated a simcha...heartbreaking. The nicest, NICEST guy, the nicest wife. He took care of her like a queen."

Yaakov Vishnevsky of Lakewood related the following to me: His wife's grandmother's sister was a healthy 95-year-old woman. Everyone in her family got the shot. Everyone else got sick, but recovered (for now). However, the 95-year-old great aunt passed away in her sleep after taking the vaccine. Yaakov Vishnevsky's number is: (215) 421-8539.

-On the note of reproductive disorders post-vaccine, the story that was going around about the man in Lakewood with the terrible vaccine reaction, which created a problem having children (to put it delicately) was personally verified by Yaakov Vishnevsky, who tracked the family down.

-Yaakov Vishnevsky also has heard a number of stories of kidney failure after the vaccine, and I personally just heard a very recent story of kidney failure in a prominent man in the religious Jewish community after he received the corona shot.

-A woman named S. G. shared: "My friend in Israel just told me her friend has kidney failure after the second dose. And that friend says her other friend is having the same."

-Mrs. Pinto, in Israel, told me that her cousin has a nursing home in Yerushalayim. He started administering the vaccine to his residents. All 12 of the people who received the vaccine passed away within 2 days. He stopped giving the vaccine in his nursing home. Mrs. Pinto's number is: +972 55-563-4704.

-G. S. said: A close friend (who did not want the shot but finally gave in following enormous pressure from community and family) is still trying to recover 3 and a half weeks following the first shot. She could hardly stand nor eat the first week, had terrible nausea, diarrhea, dizziness, weakness, pulsing sensations. She has been working with a homeopath and acupuncturist, and, B"H, there has been some improvement, but the diarrhea, weakness, and lack of appetite keep recurring. Following all-night-in-the-ER blood tests last week, she was told "tests are fine, you're healthy" (and implied no reason she can't get the second shot - yes, really...).

-Batsheva posted the following stories she knows personally: "Sadly, I just heard firsthand of a 40 something-year-old woman who didn't get Covid all year even though her whole family had it, and she was with them. Now, she took the

vaccine and died 4 days afterward. Of course, they're saying she caught Covid while waiting on line for the shot! Also, I know of an 18-year old that started having heart problems 3 weeks after the second dose and the family is in denial that it's from the vaccine."

The healthcare provider with whom I collaborate said: "I have lots of stories – most of my day today was working with doctors trying to come up with treatments for the more serious reactions. **The actual cases that I have personally seen include: neurological damage, muscle weakness, fatigue, psychosis, brain inflammation, life-threatening diarrhea, cognitive disorders, pneumonia, preterm labor, tachycardia, lung damage, depression, and personality changes.**"

"I had another '6 weeks after second shot' person today. Nervous system collapsing and cognitive difficulties. Feels like his brain is trying to flee his head."

"I hear from my colleagues that from about two weeks or more after getting the vaccine, people are **getting pneumonia, often double pneumonia**. I personally saw two cases, plus one case six weeks after the second shot, who had a **rare lung infection**."

"My first call in the morning was from a woman who got her first shot 6 weeks ago. She's had diarrhea ever since and is weak and dizzy, and she can't think straight. As I was trying to arrange to get treatment to this woman, I got a call from a man who'd gotten his second shot. He felt like his brains were blowing out of his head, and he reported all kinds of sensory issues, like smelling and tasting and hearing things that weren't there, and a sense of foreboding, panic, and depression that weren't part of his normal personality. Soon afterward, I got a call about a woman who is 7 months pregnant and received her first shot last week, and wasn't doing well."

"It has been my experience that the side effects of the first shot appear to respond to treatment, but after the second shot I have not yet been able to treat these side effects nor do I know anyone else who has had success either."

From a conversation with this provider about whether people can suddenly collapse a few months post-vaccine when they previously appeared ok: "I just heard of that happening tonight. My family member was speaking to a Rav he is close with, who said that he was in the Kupah waiting his turn when the guy who works there (all are forced to get the shot) collapsed without warning right in front of him! This Rav had had the first shot, but when he saw all the guys in his yeshiva getting sick after the first shot (including himself), he refused the second."

**ALL THE ABOVE STORIES CORRELATE PERFECTLY WITH THE WARNINGS OF a doctor in a video I watched, IN WHICH SHE WARNS OF EIGHT "KILL MECHANISMS" THAT THE CORONA VACCINE POSSESSES.** Dr. Tenpenny explains how the spike protein, and the anti-spike protein antibody that the vaccine induces the body to produce, are deadly. A summary: The antibody is not like a natural antibody that the body produces naturally in response to a virus. Based on scientific papers she researched, she predicted attacks on two types of brain cells in the central nervous system (astrocytes and oligodendrocytes), the inner mitochondria membrane, and the motor neurons. **Now you can understand post-vaccine reactions being seen, such as severe fatigue, inability to walk, and nonstop shaking.** The pancreas can also be attacked, resulting in diabetes, as can the lung tissue and many other types of bodily tissues. The M2 (anti-inflammatory) macrophages can be inhibited, resulting in cytokine storm. Dr. Tenpenny points out that there is no off-switch to stop one's cells from manufacturing the spike protein once a person has received the injection. **It is crucial to realize that these autoimmune disorders are NOT immediate reactions. According to this doctor and other expert doctors and scientists weighing in on this subject, such as Dr. Michael Yeadon, it will take 6 months to a couple of years for most people to come out with the symptoms. If we keep running full speed ahead with injecting everyone, just imagine the nightmare scenario we will be facing, chas v'shalom.**

## CHILDREN:

**A 12 YEAR OLD GIRL IN THE JEWISH COMMUNITY TOOK THE VACCINE IN ORDER TO GO TO ISRAEL, AND BECAME PARALYZED.** I spoke personally to someone with a connection to the family and verified this story.

**WE RECEIVED A TEXT TO DAVEN FOR ANOTHER YOUNG GIRL WHO WAS UNDERGOING SURGERY TO REMOVE A BLOOD CLOT BY HER HEART, AFTER THE VACCINE.**

Maddie, a 12-year-old girl in Moderna's vaccine trial, is now paralyzed from the waist down, unable to urinate on her own, requires a feeding tube, and has been suffering from a bowel obstruction, excruciating pain, fainting episodes, and other neurological problems.

All the VAERS reports below can be verified at [medalerts.org](https://www.medicare.gov/medwatch/alerts). The following are some of the deaths, but there are many grave injuries in children as well, such as blood clots requiring multiple surgeries to remove, seizures, and myocarditis, an inflammation of the heart muscle that is not only dangerous but can leave lifelong effects, such as congestive heart failure. (Strangely, there is documentation that the CDC and FDA knew about the threat to the cardiovascular system from the corona vax by December 21, 2020, yet went ahead with it, anyway.)

VAERS ID 1187918, 15-year-old female in New Hampshire, death from cardiac arrest about three to four days after second Moderna vaccine.

VAERS ID 1218081, 17-year-old female in Wisconsin, cardiac arrest and death.

VAERS ID 1225942, 16-year-old female, Kamrynn Soleil Thomas of Waunakee, Wisconsin, cardiac arrest on March 28, nine days after Pfizer vaccine. Death on March 30. (Further details from report: "Hemodynamic collapse at home. Persistent cardiac arrest requiring ECMO. Event believed secondary to pulmonary embolism.")

VAERS ID 1242573, 15-year-old male, Colorado, heart failure and death.

VAERS ID 1255745, 2-year-old girl in Virginia, died on March 3, five days after second dose of Pfizer vaccine.

VAERS ID 1261766, 1-year-old baby boy in Florida, suffered convulsions and seizures after the Moderna shot and died two days later. (

With all the above, we are EXTREMELY concerned about reports that it is possible that authorities will soon be able to vaccinate children WITHOUT parental knowledge or consent. In fact, that is indeed the case in some places:

IT IS VERY IMPORTANT to know that children's hospitalization rates for corona have been grossly inflated, creating the impression that corona is way more dangerous for kids than it actually is. Two studies found

that at least 40% of the children who had been hospitalized "for corona" had really landed in the hospital for an unrelated cause. See

In actuality, 99.997% of kids survive corona, and that number includes kids who are immunosuppressed — which means that healthy kids have ZERO PERCENT death rate.

Neither is there any need to worry about "long Covid," as ivermectin both prevents and treats long Covid. Sadly, though, many of the same doctors who refuse to consider this innocuous drug that has a 30-year safety record, are the SAME doctors who are pushing the brand new experimental gene therapy shot on kids — the same "vaccine" which has NO safety record and has already caused blood clots, myocarditis, and worse in so many kids who NEVER NEEDED IT TO BEGIN WITH!

Here is an interview with Dr. Byram Bridle M.D., Associate Professor of Viral Immunology at the University of Guelph, lightly edited for clarity. You can listen to the interview at

(Alex Pierson) Doctor, you have been very open on this whole issue. You're not an antivaxer by any stretch. But what do you think about this inflammation of the heart [experienced by dozens of Israeli teens and young adults in Israel, 22 and below]. Is it an actual threat?

(Byram Bridle, MD) As you said, I am very much pro vaccine but I'm always making sure that the science is done properly and we follow the science carefully before going into a public role over the vaccines.

I'll forewarn your listeners that the story I'm about to tell is a scary one!

This is CUTTING-EDGE SCIENCE. There [are] a couple of key pieces of scientific information that I've become privy to in the past few days that have made the final link so that we understand now exactly why these problems are happening, as well as many other serious side effects that are associated with this vaccine.

Let me assure you that everything that I'm going to state right now is COMPLETELY BACKED BY PEER- REVIEWED scientific publications in well-known and well-respected scientific journals.

The SARS corona virus 2 has a spike protein on its surface. That spike protein is what allows it to infect our bodies. That is why we have been using the spike protein in our vaccines. The vaccines we're using get the cells in our bodies to manufacture that spike protein. If we can mount an immune response against that protein, then in theory we can prevent this virus from affecting the body.

That's the theory behind the vaccine.

However when studying the disease, heart problems, lots of problems with the cardiovascular system, bleeding and clotting, is also associated with severe Covid 19.

And doing that research, what has been discovered by the scientific community is that the spike protein on its own is almost entirely responsible for all the damage to the cardiovascular system....if it gets into the circulation.

Indeed if you inject the purified spike protein into the blood of research animals, they get all kinds of damage to the cardiovascular system, and IT CAN CROSS THE BLOOD BRAIN BARRIER and cause damage to the brain.

Now, at first glance that doesn't seem too concerning because we are injecting these vaccines into the SHOULDER muscle. The assumption, all up until now, has been that these vaccines behave like all of our traditional vaccines, that they don't go anywhere other than the injection site. So we assumed that they stay in the shoulder. Some of the protein will go to the local draining lymph node in order to activate the immune system.

However, this is where the cutting-edge science comes in, and THIS IS WHERE IT GETS SCARY:

Through a request for information from the Japanese Regulatory Agency, myself and several other international collaborators have been able to get access to what's called a bio distribution study. It's the first time ever that scientists have been privy to seeing where these messenger RNA vaccines go *after* vaccination.

In other words, is it a safe assumption that it stays in the shoulder muscle?

The short answer is: ABSOLUTELY NOT! It's very disconcerting.

The spike protein gets into the blood, and circulates through the blood in individuals over several days post vaccination. Once it gets into the blood, it accumulates in a number of tissues, such as the spleen, the bone marrow, the liver, the adrenal glands...one that's of particular concern for me is that it accumulates in quite high

concentrations.

A scientific paper about 13 young health care workers who had received the Moderna vaccine was just accepted for publication. It CONFIRMED this: They found that the spike protein was in circulation, so it was in the blood of ELEVEN of those 13 health care workers who had received the vaccine. What this means is: We have known for a long time that the spike protein is a PATHOGENIC protein, it is a TOXIN, it can cause damage in our bodies if it gets into circulation. Now, we have clear-cut evidence that the vaccines that make the cells in our deltoid muscles manufacture this spike protein...the vaccine itself plus the protein gets into blood circulation.

When in circulation, the spike protein can bind to the receptors that are on our platelets and the cells that line our blood vessels. When that happens, it can do one of two things: (1) it can either cause platelets to CLUMP and that can lead to CLOTTING, that's exactly why we've been seeing CLOTTING DISORDERS associated with these vaccines. (2) It can also lead to BLEEDING. And of course, the heart is involved! It's part of the cardiovascular system. That's why we're seeing HEART PROBLEMS. The protein can also cross the blood-brain barrier and cause neurological damage. That's why also in the fatal cases of blood clots, many times it's been in the brain.

And also of concern, there is evidence in a study that has not yet been accepted for publication; in this one, they were trying to show that the antibodies from the vaccine get transferred through breast milk. And the idea was that this may be a good thing because it could confer some possible protection to babies.

However, what they found, inadvertently, was that the vaccines, the messenger RNA vaccines themselves, not just antibodies, actually get transferred through the breast milk. So that is delivering the vaccine vector itself into infants that are breastfeeding.

Also with this, now we know that the spike protein gets into circulation, and any proteins in the blood get CONCENTRATED in the breast milk. Looking into the [VAERS] Vaccine Adverse Events database in the United States, we have found evidence of nursing infants experiencing bleeding disorders in the gastrointestinal tract.

This has implications for blood donations! Right now, Canadian blood services are saying that people who have been vaccinated can donate....But we disagree! *We don't want transfer of these pathogenic spike proteins to fragile patients who are being transfused with that blood! This has implications for infants that are breastfeeding.* And this has serious implications for people for whom SARS Corona virus 2 is not a high risk pathogen AND THAT INCLUDES ALL OF OUR CHILDREN!

In short, the conclusion is WE MADE A BIG MISTAKE! *We didn't realize it until now, we thought the spike protein was a great "target-antigen."* We never knew that the spike protein itself WAS A TOXIN.

So...by vaccinating people, we are inadvertently inoculating them with a toxin. Some people, it gets into their circulation, and when that happens, in some people that can cause damage, especially in the cardiovascular system. I have many other legitimate questions about the long-term safety of this vaccine. For example, in the example of it accumulating in the ovaries, it will be rendering some young people infertile.

Here is a very partial list of the thousands of doctors and scientists worldwide who are raising the alarm about the covid injection:

"None of the trials currently underway are designed to detect a reduction in any serious outcome such as hospital admissions, use of intensive care, or deaths. Nor are the vaccines being studied to determine whether they can interrupt transmission of the virus."

Pfizer and Moderna's "95% effective" vaccines—we need more details and the raw data...According to FDA's report on Pfizer's vaccine, there were "3410 total cases of suspected, but unconfirmed covid-19 in the overall study population, 1594 occurred in the vaccine group vs. 1816 in the placebo group...Addressing the many open questions about these trials requires access to the raw trial data. But no company seems to have shared data with any third party at this point.

**Dr. Vanessa Schmidt Krüger**, Cell Biologist, Scientific Research Group at Max Delbrück Center for Molecular Medicine (MDC) Berlin

"I am extremely critical of the EMA Committee: there is no discussion at all about the consequences that can arise from side effects. They just nodded it all through. They just said ok, that's how it is ..." "No genotoxicity studies done yet. They say they don't need to because "no genotoxic potential is to be expected". But it has been known for 20 years that cationic lipids are highly toxic. What universe do they live in!?"

**Geert Vanden Bossche**, DVM, PhD, Vaccine Researcher, former Chief Scientific Officer (CSO) and Chief Innovation Officer (CIO) at UNIVAC NV

"Mass infection prevention and mass vaccination with leaky Covid-19 vaccines in the midst of the pandemic can only breed highly infectious variants."

"From all of the above, it's becoming increasingly difficult to imagine how the consequences of the extensive and erroneous human intervention in this pandemic are not going to wipe out large parts of our human population. One could only think of very few other strategies to achieve the same level of efficiency in turning a relatively harmless virus into a bioweapon of mass destruction."

"This problem of ADE is a major reason why many previous vaccine trials for other coronaviruses failed. Major safety concerns were observed in animal models. If ADE occurs in an individual, their response to the virus can be worse than their response if they had never developed an antibody in the first place... ADE has proven to be a serious challenge with coronavirus vaccines, and this is the primary reason many of such vaccines have failed in early in-vitro or animal trials." "If this were to be the case this would then also prevent the formation of a placenta which would result in vaccinated women essentially becoming infertile...it could take a relatively long time before a noticeable number of cases of post-vaccination infertility could be observed."

### 93 Prominent Doctors in Israel signed a Letter against Vaccination of Children

"...The increasingly prevalent opinion within the scientific community is that the vaccine cannot lead to herd immunity, therefore there is currently no 'altruistic' justification for vaccinating children to protect at-risk populations... We believe that not even a handful of children should be endangered through mass vaccination against a disease that is not dangerous to them. The Sassover Rebbe recently related that in 5740 he discussed an important medical issue with Rav Elyashiv, zt"l, for two full hours. What will happen if after some time someone will become injured from it?" The Sassover Rebbe then stated: "This was said about something that was on the market for a few years already, and it was used in half the world. Thousands of doctors worldwide were involved in it. [This was] not [a product] that was just a few weeks old, and [produced] by just a few companies. And about it he said: 'How is it possible to take achrayus?' It is forbidden to take it b'shum ofen ba'olam."



When asked about the corona vaccine, Hagaon Hatzaddik Rav Yaakov Meir Shechter, shlita, responded: "My opinion is that one should not take the corona vaccine b'shum panim v'ofen."

## פסק הלכה

מאת הפוסק הגאון רבי משה מרדכי קארפ שליט"א

*The following are excerpts from a Psak Halacha written on the second of shevat (Erev Shabbos Parshas Vaera) by the great posek Hagoon Rav Moshe Mordechai Karp shlita, a well-known mechaber seforim and Rav in Kiryat Sefer, who received an accumulated twenty five years of shimush under Harav S. Z. Auerbach zt"l and Harav Y.S. Elyashiv zt"l: (translation)*

...Regarding the vaccines; many have expressed opposition to them, including doctors and experts. The vaccine was produced in confusion and haste, by parties who have many self-serving interests, as it is well-known. The vaccine producers themselves and those that gave the temporary approval have publicized the hazards [involved].

...However, a few weeks have already elapsed since people have taken the vaccines, and it has become known to us many horrific cases of previously healthy people who took the vaccine and were very harmed afterwards, and some even died Rachmana litzlan. We have read what the vaccine companies themselves warn, that there are many extremely serious side-effects that are liable to occur. Before the vaccinations began, we thought that they wrote this to protect themselves from legal claims etc. However we now clearly see, [even] in this short time period, that the damage is very great. And although the great majority of people were not harmed, and may it be Hashem's will that they will not be harmed, however the fact is that a great many were harmed from it. One may not comprehend from the directive of the Gedolim that was given before the vaccinations, how to act now following the vaccinations, [when we have seen] the great damage of the vaccinated, [or at the very least there is suspicion and a strong basis that the damage came on account of it]

We find the view of Gedolei Hadoros concerning vaccines in the Sefer HaBris (מאמר יד' עמוד שכט), which is a trusted source accepted throughout [Klal] Yisroel. When vaccines became available for the small-pox plague which then existed, he wrote: "However in our time, with the kindness of Hashem, a new medication was produced which protects one from the pox... And it has already been tested by tens of thousands of people who all were left unharmed from it, with not even one person dying. And it was when the Chachmei Yisroel saw that that the matter had been thoroughly tested, and the practice continuously spread and was accepted in all countries worldwide, and no harm or impairment was heard or seen to any person, young or old, for it was a harmless item, the Ziknei Yisroel and Tofsei HaTorah in this generation permitted it to all of Yisroel according to the Torah... For, owing to the kindness of Hashem, it is safe from any impairment and from any bad thing, as proven from the daily test of tens of thousands of people, this for about thirty years... Therefore, this practice started to spread also among our people."

We can thus see the outlook of Gedolei Yisroel regarding vaccines:

- 1) They waited an extended period of time [about thirty years]
- 2) They checked out the outcome [of those that were taking it] in all countries worldwide.
- 3) Only when they saw that it didn't harm anyone – young and old – over a long period of time, the Gedolei Yisroel permitted it And although the issue then was the small- pox plague, when many were dying in the streets, and this was a great salvation, **nevertheless, one may not carry out an act of damage to himself or others.** And what is there to say; [today] not one of these conditions has been met!! For we have seen that in a short time span many have been exceedingly harmed. It is pashut that there is no heter [to take it]!! And certainly since even a minimal testing time has not elapsed, as it is known. And not all the countries have permitted it; as some countries have not authorized it, and other countries in the world are waiting to see the outcome and damages from Eretz Yisroel.

And this that [some] say; the young should wait, and only the elderly should be vaccinated. Here we saw how totally uninformed [people are]. For specifically [regarding] the extremely elderly we have seen that they have been incredibly harmed in this matter, for they don't possess the strength to handle it. And furthermore; we have heard of two old-age homes in Yerushalayim Ir HaKodesh, where there were practically no sick cases. [Yet] from the time that they vaccinated, the sick increased, and many sick were even transported to the hospital.

**And certainly whoever possesses any intelligence, will not entertain the thought of taking these vaccines, but rather will abstain until a longer time passes, and the effects and outcomes are seen.**

And regarding one who has already taken these vaccines; he should not worry, but should only trust in Hashem, for it is only in His hand to aid and heal. And even if one experiences side- effects, one should strengthen in bitachon and joy in Hashem, and not worry at all, and Hashem protects those who take refuge in Him...

The following are excerpts from a speech given on the tenth of Teves 5781, translated from Yiddish, from the recording

...I was asked to voice my opinion regarding the COVID vaccine. It says in the Passuk - "בשרתי צדק..." - "It's forbidden to keep his mouth back from informing them what the people need to know."

I was asked a few times to voice my opinion either in writing or orally. Firstly, I would like to clarify that I am not coming to rule and to say you should accept my opinion. I'm just pointing out the different points to the public - and the reality of the matter - in order that they should be able to decide on their own...

...Therefore, for quite a few months already, I have been learning the Sugya of vaccines, and I have read many informative articles written by doctors in Eretz Yisroel & in Chutz L'Aretz. Additionally, I have also personally spoken to some of these doctors.

- One needs to know that there is a clear Halacha in Hilchos Ta'anis on the definition of what is considered an epidemic. There are rules regarding how many people have to die in how many days. It cannot be that these deaths be attributed to other things. Only then can one justly claim that it is an epidemic. According to all the given facts and parameters that exist here - at least here in Eretz Yisroel - it contradicts what they say - which is that Corona is an epidemic. And I'm saying it from the facts that I know. One of the Rabbonim here in the city - publicized the Shita of מימונית - on the subject of epidemics - the numbers aren't calculated and established according to how many died, but rather on how many are sick. I would like to say that there is no end to the amount of people that received a test result claiming that they are positive and it was a complete lie. There are those that have money and verified this theory by going to a different lab and having the result come out negative. There are also those that received a phone call claiming that their test result is positive - and they answered - "Excuse me, I never went for a Corona test." There are endless testimonies from many people about this. Additionally, 2 very big doctors told me that all of those that tested positive as being carriers of the Corona virus are not sick - they just carry the virus. Every person has many germs and viruses inside of them - but it doesn't harm everyone. Many more people are positive for flu - and it doesn't harm everyone and not everyone gets sick from it. Therefore - as long as a person doesn't get sick from the virus - there is nothing in the fact that the numbers are rising every day. Suddenly - the numbers are rising for the frum people. In the months of Tishrei & Chanuka - they raised the numbers a lot - and according to them - I don't want to mention with my mouth what should have been R"L according to their words...and it wasn't anything of the sort. Now, again they are raising the numbers - it's going up by the hundreds each day. Whoever wants to believe them should believe them - but it's a shame that the media are posting all of these numbers on all of their notices. The frum newspapers are also putting the people into big confusion.

- One of the Rabbonim wrote and said that the reason one needs totakethe vaccine is because of אין ספק מוציא מידי וודאי - a doubt can't override a certainty. Since it is definite that there is a pandemic and it is a ספק if there is a danger in the vaccine - therefore וודאי מידי וודאי. As stated earlier - there isn't a definite of a retired. This has to be understood. The old people that are ממלאכתן בטלו - don't need to live?! Why aren't they taken into account? Behold! We don't give up on one single Yid! But the reason is that there are rules in the Torah of what determines what is a pandemic, what is considered חולי מגיפה. Whoever is old already, there are many more reasons why he became sick or C"V worse than that. This is why they are not taken into account. And therefore we don't have a definite number - and it's obvious that we don't have the אין ספק מוציא מידי וודאי of דין.

- Another thing - In שולחן ערוך הלכות יום כבוד ה' it says that in a circumstance where there is a possibility of a danger - even if there are **2 doctors that hold and have an opinion against that of 100 doctors** - the opinion of the 2 doctors must be accepted against the opinion of the 100. Regarding the issue of the vaccine - I'm telling you that there are many more than 100 that do say to vaccinate - but the Halacha is that when there is a minority that oppose - we have to be חושש of that minority. There were a few meetings and **doctors that came forward to notify their opinion against the vaccine**, and security was needed so that it shouldn't be publicized that they voiced their opinion against the vaccine. If the government would hear that they spoke against the vaccine - they would be called for a "hearing" and lose their positions. Doctors are afraid to say the truth. In addition, one of the heads of the manufacturers of the vaccine - I don't want to mention a name - **but he himself said that there is a possibility of infertility, and a possibility of a change in the D.N.A. - it could very likely happen.** This was out in the open and advertised in the media in Chutz L'Aretz - millions heard about it.

- There is another thing - all of the doctors that are explaining the dangers of the vaccine are just bringing the facts to the public - but they are not telling the public what to do. They prove their words with studies that are written up and proof in regard to what the manufacturers did in the past with the Polio & Tetanus vaccines in Africa - and the terrible consequences that resulted from it. **All those that do say to take the vaccine - no one is bringing any proof in writing.** They just say that you don't have to be scared - that the dangers are too far-fetched, and all of the tests were made already. No proof in writing. On the contrary - let them prove it and then we'll see.

- One of the Rabbonim - unbelievable what he wrote in a letter to the public - in שולחן ערוך in the Halachos of גוסס חולה - he wrote on what the author Paskened - which is that the doctor has to receive permission from the Beis Din - and on this he wrote that שהאידיא בזמנינו - in our times - the doctor needs to get permission from the government. Therefore, because the doctors have permission from the government - the decision from the doctors is considered as the decision of the Beis Din. The manufacturer of this vaccine was sued in the world by hundreds of thousands of people for crimes against mankind from different vaccines that he distributed in different countries where people were harmed terribly from their effects. Who amongst us puts their trust in the government? One of the Rabbonim said to me, "Harav Vosner - I have faith in the Ministry of Health." I answered him "I hear. You have faith in the Ministry of Health - but I know where you davened on Rosh Hashana & Yom Kippur - and what that minyan looked like. Where was your faith in the Ministry of Health?!" How can there be faith in a government that acts this way?! I want to ask another question. The Prime Minister signed a contract with the manufacturers of the vaccine a few weeks before they got an approval that

the vaccine can be used for all - and on top of that paid a few million Shekel for it. Behold, this person has a letter of approbation against him on money extorted illegally - and he goes and publicizes it to all the Yidden - and orders vaccines that have no approval - and one of the deliveries arrived even before approval - and there is no explanation for it. He seems to just know that the vaccine will get an approval. If you think that the approval depends on different studies and testing - how can you possibly know beforehand that the tests came out positive and were approved? Prophecy was given to the fools - but not to the Reshaim. How did the Prime Minister know that the vaccine will be getting an approval?! It's a question that I asked and no-one gave me a plausible answer for it. The government goes ahead and gives a permit to the Ministry of Health - and they determine Halacha to Pasken like a Beis Din?! I'm surprised! I'm just asking/questioning on the Rav in Am Yisroel that publicized such a Psak to the people. At the United Nations Headquarters there was a meeting a bit ago. There is a paragraph in the summary of points from that meeting called "Agenda 2021 - with many signatures of Prime Ministers & Presidents. I think that the Prime Minister of the Medinah also signed on it. What it says in this paragraph is that there are roughly 7.8 billion people in the world and it's too difficult and too much for the world. There are a few studies on it - and they want to achieve that in the end there will only remain about 2 billion people. Diluting the population became an agenda. And these are things that they wrote about and signed on them. Let's think for a minute - how are they going to dilute the world? How will they do it? Shoot the people like in China? Slaughter people and put them in refrigerators? How will they achieve this plan of dilution? Think about it.

- Another thing that one of the Rabbonim told me in the name of a couple of Gedolim that in E"Y it was always known that we rely on the doctors. We know how much our grandfather - ZT"l didn't rely on the doctors. How many times the well-known Medical Askanim came to the Rebbe, to the house and the Rebbe argued with them. Until today - I meet with the doctors - on certain areas - and they say to me - "Your grandfather was against and we respect it until today"...

...It's very clear that whoever has a heart problem won't seek the advice of an eye doctor - even if he has a permit from the government to be a competent eye doctor. He can't diagnose or give information at all. He cannot be included to compose a majority. **A doctor that hasn't studied and investigated many, many years on the subject of viruses - and not just that - a doctor that didn't study and research for many years the components of vaccines and their effects can't express his opinion on the topic of the vaccine.** It's like an eye doctor or reflexologist that expresses his opinion on whether to do open heart surgery or not. The entire concept of asking a doctor is madness. **All vaccines go through a minimum of between 5 - 10 years of testing and experiments.** This test barely passed 6 months of testing because it's as if it's an emergency - and therefore the process of the experimental tests and all that's included were done using short-cuts. But דדינא מעיקרא פראב established that it's "emergency time" now and you have to take a vaccine. It's like one who burns down the house of his

## YOU ARE ENTITLED TO KNOW...

Pertinent questions for anyone thinking of stretching out their or their child's arm for the injection...

1. **ARE YOU AWARE** that the FDA<sup>1</sup> classifies the Covid-19 vaccine as an "investigational new drug", and repeatedly states that the Covid19 vaccine was not granted approval? And that as per the FDA this vaccine has "not undergone the same type of review as an FDA-approved or cleared product". It was merely given a temporary authorization for use in what they classify as an "emergency" although it is still in middle of the trial.  
(To confirm the above-mentioned information, call the Pfizer Company 1.800.879.3477 and then press 1 and then 3 to speak to a representative. As you wait, you will hear a recording stating that the vaccine is not approved by the FDA.)
2. **ARE YOU AWARE** that the expected time for the corona vaccine to be "approved" by the FDA, is not before the year 2023, if at all? Are you aware that the FDA demands that the manufacturer continues to assess the risks through tracking the long-term side effects of those being currently vaccinated, in order for the vaccine to be approved?
3. **ARE YOU AWARE** that the state of Israel and its media networks went out with an all-out campaign claiming that the corona vaccine is approved by the FDA and that it was proven to be safe and risk-free, and only after a claim against this outright lie was filed

to the high court did they back down and remove these statements, but this was after they already managed to inject five million people through telling them false information?

4. **ARE YOU AWARE** of a severe fatal side-effect which may occur in all coronavirus vaccines within months or even years after taking the vaccine? The manufacturers have identified (and reported to the FDA) vaccine-associated enhanced disease as "an important potential risk". (This is also commonly known as A.D.E - Antibody-Dependent-Enhancement. What it means is that there is a risk that [primarily when the vaccine induced antibodies begin to wane] upon exposure to a variant of the virus, instead of neutralizing and killing the virus, the antibodies will enhance the virus – making it much more severe than if no vaccine had been taken. Indeed, this fatal side-effect has already occurred in the past during animal trials for vaccines against diseases from the coronavirus family. Although initially the animals showed a good immune response against the virus, when they were later exposed to a virus variant, they either died or became severely damaged. For this reason, up until now, no vaccine has been approved for any coronavirus.) Are you aware that no authoritative organization has issued a contrary statement that this risk is ruled out? [Note: The risk of A.D.E that was identified in the vaccine is much more severe and prevalent than side effects that are listed on regular medicines, which are rare and minor, and were ruled out after years of tracking prior to mass distribution.]
5. **ARE YOU AWARE** of the risk of irreversible damage to the liver, potentially even causing death of the vaccinated persons (as per the report of the manufacturer to the SEC – U.S. Securities and Exchange Commission) as a result of the PEG ingredient found in the vaccine? This casualty has already occurred in the past. [There are additional risks associated with the PEG ingredient, yet this specific risk has been reported by the manufacturer to the SEC, since the high probability of its occurrence requires an official report.]
6. **ARE YOU AWARE**, that the expertise on vaccines and viruses is "exclusive" to biology experts (such as: virologists and immunologists), while other doctors and medical advisors branded as "experts" – are not equipped with knowledge in this field on their own? They rely on opinions from medical authorities (which are often biased), and it is therefore irresponsible to consider them experts who are supportive of the corona vaccine. Are you aware that there are numerous senior and world-renowned biology experts (who the public relied upon for their expertise in the field of viruses and vaccines) who are openly expressing their opposition to the corona vaccine? These experts are deriving no personal benefit from relaying their disapproval. Quite the contrary, they are being ostracized and penalized for admitting the true facts to the public.
7. **ARE YOU AWARE** that the mRNA vaccine operates with a completely new form of technology which was never used on the general public?
8. **ARE YOU AWARE** that all previous attempts from the manufacturers (Pfizer and Moderna) to create a vaccine using the new mRNA technology on humans (before the corona pandemic – year 2017), failed and were not able to be approved? Are you aware that the "emergency use authorization" for the corona vaccine was unprecedentedly issued after a short duration of trials in the year 2020?<sup>2</sup>

2. The trial lasted only two months when the official tracking of the participants was abruptly stopped. The members of

9. **ARE YOU AWARE** that it is established in the medical world (as per the protocols of the FDA and the rest of the established medical organizations worldwide), that there is a long-term trial required for every new vaccine – in order to observe its risks and side-effects? It is not feasible to rush the process since **assessing the body's reaction to the vaccine requires a minimum of several years.**<sup>3</sup> **Just in the last 3 years, the FDA disqualified over 300 new treatments and vaccines due to risks that only became apparent during long-term trials of several years, and that in the beginning were completely unknown!**

10. **ARE YOU AWARE** that from essays written by scientists who work for the corona vaccine companies it is evident that there are severe risks in giving it to **immunocompromised individuals?** (And there is a significant percent of the public that is included in in this category.)

Do you have an explanation for the obsessive propaganda and pressure applied by the health organization on the “at-risk” population “to run and get vaccinated” – **without informing them of the risks involved due to their weaker immune system?** (Do you have an explanation why when the side-effects did occur, the health care providers blamed them on their underlying conditions?)

11. **ARE YOU AWARE** that people under the age of 60, which the data shows that the vast majority of them are not in any risk if they contact COVID, are nevertheless being brainwashed to vaccinate with the “reasoning” that this is how their lives will return to “normal.” At the same time, authorities are making official announcements that there are new virus mutations for which the vaccine does not seem to work against, and therefore they **cannot go back to “normal”**. If so, what is the logic of pressuring them to vaccinate?

Is there any logical explanation for vaccinating masses of adolescents (who have almost zero risks from COVID) when there were **just a few tens** of trial participants in this age range (out of the 44,000 participants), and when **many of the irreversible risks (e.g. infertility) were not ruled out, according to the FDA?**

12. **ARE YOU AWARE** that, according Pfizer, the vaccine-induced immunity will last only for a limited amount of time – in the words of Israeli Prime Minister Bibi Netanyahu “it will expire” (which is why the plan is to vaccinate the entire population again with a third dose in the near future, and then continuously). In contrast, those who possess immunity from the natural Corona infection, according to senior officials of the Israeli Health Ministry (as stated in a priorities committee session), only a fraction of a percent are likely to get reinfected, and only with very light symptoms!

Do you have a logical explanation for the recommendation of public health officials to vaccinate those who have recovered from corona, especially in light of the fact that there are scientists and doctors who warn that the vaccine may be particularly harmful for them?

the trial were then merely left with an option to report side-effects. In addition, the companies prevented any possibility of proper tracking, since they immediately gave the real vaccine to the placebo group, claiming that it was unethical to leave them “unprotected” from COVID, (although most of them were not in the “at-risk” group). In this way, they actively disrupted any proper trial follow-up.

3. This is unlike the technical bureaucratic functions in the first stages of development, before the stage of actual trial, which can be hastened through increased funding, international cooperation etc.

13. **ARE YOU AWARE** that as per the European Union and the U.K., it is a **severe criminal offense to vaccinate expectant women** (unless a woman requests the vaccine on her own), since they were excluded from the trials? Thus, is there any rational explanation of encouraging women to vaccinate during this period?

14. **ARE YOU AWARE** that there are non-stop reports on social media from pregnant women who shortly after taking the vaccine lost their babies? And from women reporting serious women's- problems after taking the vaccine.

15. **ARE YOU AWARE** that a new biological study regarding the corona vaccine (which only creates anti-bodies against the spike protein), reveals that the anti-bodies which are meant to attack the spike protein are also **liable to attack the essential protein located in the brain**. It is well-known and proven that any damage to this protein can cause extremely severe side-effects.<sup>4</sup>

The study of how the antibodies from this new type of vaccine work was published in “Frontiers in Immunology” on January 19, 2021, and was conducted by three world-renowned experts, **Aristo Vojdani, Elroy Vojdani, and Datis Kharrazian** (See below for their titles.)<sup>5</sup>

16. **ARE YOU AWARE** that senior authoritative researchers in different countries (e.g. professionals in the Miami University) are conducting a study on the fact that the corona vaccine can **impair both men and women from the capability of having children?**

17. **ARE YOU AWARE** that there are senior renowned scientists (including **Dr. Michael Yeadon**, former vice-president of Pfizer, and **Dr. Wolfgang Wodarg**, former head of the European Health Council) who expressed concern that the corona vaccine can **attack an essential protein** (aside from the risk mentioned in the previous clause), **thereby causing infertility in women?**

18. **ARE YOU AWARE** that there are **short term side-effects which have already occurred after taking the vaccine**, (not referring to the long-term risks mentioned above), including becoming infected with rare and unusual sicknesses, as well as **many instances of strokes, heart-attacks etc. which have led to death (sometimes within mere hours) after receiving the vaccine?**<sup>6</sup>

4. This is unlike natural anti-bodies (developed from contacting the virus as opposed to anti-bodies created by this new type of vaccine). Although they also attack the spike protein, there is no risk of them causing damage to this essential protein. Why is this so? Since the natural anti-bodies are not concentrated in such a high quantity like the anti-bodies built from the vaccine, since they fight together with other types of anti-bodies against all the proteins of the virus. In this way, they do not have enough power to damage this essential protein. Conversely, the anti-bodies created from the vaccine are all specific against the spike protein, and are therefore concentrated in a large quantity. **In this way, they have the ability to damage the essential protein in the brain.**

5. **Aristo Vojdani** from the Department of Immunology, Immuno-sciences Laboratory, Inc., Los Angeles, and the Department of Preventive Medicine, Loma Linda University School of Medicine, Loma Linda, CA; **Elroy Vojdani** from Regenera Medical, Los Angeles; and **Datis Kharrazian** from the Department of Preventive Medicine, Loma Linda University School of Medicine, Department of Neurology, Harvard Medical School, Boston, and the Department of Neurology, Massachusetts General Hospital.

6. It is interesting to note that most of these casualties do not receive any public exposure. The incidents which do make it to the news, receive the indifferent response from the Health Ministry of: “we assume that there is no connection to the vaccine”. They then try to link the incident with any possible excuse other than the vaccine. Such as, on January 10, 2021 when instances of paralysis of the right half of the body were reported as a result of the vaccine, the health ministry stated that since those effected were smokers, they cannot link the casualty to the vaccine...” Is it not a wonder that up until today, we have never heard that paralysis results from smoking?

19. **ARE YOU AWARE** that the following condition is stated in the cooperation agreements between the world health authorities and the vaccine companies: **There will be no ability to claim compensation from the companies in the event of damages and deaths resulting from the vaccine?**

20. **ARE YOU AWARE** that in the near future (October 2021), the Israel Health authorities have plans to vaccinate with a third dose all those who have already been vaccinated with two doses, and then they plan to **repeatedly vaccinate them with booster shots for the rest of their lives?!**

On the tenth of Iyar, 578122) <sup>nd</sup> of April, 2021), a statement by the CEO of Pfizer was publicized in which he stated that a third dose will be needed in 6 months to a years' time. On the twelfth of Iyar (24<sup>th</sup> of April, 2021), the Israeli Prime Minister noted this as something which is absolute and settled (He announced that the people should "Prepare the shoulders"). On the thirteenth of Iyar (25<sup>th</sup> of April, 2021), Nachman Ash, an Israeli official, responsible for all corona projects in Eretz Yisroel, publicized that it is highly likely that the population will need a third dose in the near future, and in a media interview on the fifteenth of Iyar (27<sup>th</sup> of April, 2021) he explained that this is needed due to the waning of vaccine-induced immunity, as well as the appearance of virus variants that are resistant to the vaccine.

21. **ARE YOU AWARE** that during the corona vaccine trial, no tracking was done to assess if the vaccine has the ability to prevent 'infection' (meaning one who is vaccinated can still get infected with the virus and transmit it to others). The vaccine was only checked whether it can minimize 'corona symptoms' in those who get infected after receiving the vaccine.

The manufacturing companies and the health authorities declare officially, that there is no knowledge or evidence that the vaccine indeed prevents 'infection'. Thus, the vaccine does not affect "herd immunity"; it is only a personal solution for the one who is being vaccinated, (when at the same time, there exists other safer and more effective solutions).

**Hence, what rationale is there to force someone to vaccinate if he can nonetheless be a carrier of the virus, and transmit it to others, even after receiving the vaccine?**

22. **ARE YOU AWARE** that the authorities officially decided that even **those who have already been vaccinated with two doses must continue to maintain significant restrictions which were instated before the vaccines?** In the near future, discussions will continue regarding leaving most restrictions in place.

23. **ARE YOU AWARE** that it was reported already in the month of February 2021, a drastic consistent decrease world-wide in the numbers of those getting infected and dying from corona - as low as 16%? The World Health Organization has defined this as the **"decline of corona."** **This occurred before the effects of the vaccines could be noted, since the vaccination level was then less than one percent.**

24. **ARE YOU AWARE** that the death rate in Eretz Yisroel during the "corona year" (2020) remained almost the same as the previous year as reported by the Central Bureau of Statistics? (5.2 for every 1,000 people in 2020, compared to 5.1 for every 1,000 in 2019). In the past, there were years when the death rate was higher, yet they were not considered "years of pandemic." (In years 2011, 2012, & 2015, the death rate was 5.3- even higher than

2020.) **Thus, what is the rationale of a propagated vaccine campaign for the entire population, which may continue in the coming years at the expense of major risks which are still unknown?**

25. **ARE YOU AWARE** that there are many esteemed Rabbanim, who looked into the subject of the vaccines, and their definitive recommendation is to **withhold from taking it until the effects are noted, and all the risks are ruled out?** Some of them had recommended it in the past (relying on doctors or Medical Askaniem, who claimed that it was proven to be safe) but are now opposing it, after seeing the serious side-effects or after accessing information concerning risks that they had previously been uninformed of.

26. **ARE YOU AWARE** that thousands of senior and renowned doctors around the world are recommending treatments for their patients which were proven to be overwhelmingly effective in both curing and preventing COVID and other mutations of the disease? These treatments have been amassed over the past year, with experience and expertise and have been proven (on ground and in many clinical studies) to be overwhelmingly successful. (The existing treatments are inexpensive, accessible, safer than household aspirin, and actually treat the root of the disease.<sup>7</sup>) **In the event of countless simple and safe solutions to the virus, what is the rationale for propagating an untested vaccine with multiple, unknown risks?**

27. **ARE YOU AWARE** that there are thousands of Scientists, Virologists, and Doctors around the world who have openly expressed grave concerns regarding the safety of the vaccine, as well as doubts about its efficacy or necessity? They are often risking their careers and status by doing this, and we have already seen practicing doctors being given warnings by authorities to immediately cease talking about their vaccine misgivings; as well as official demands from hospitals to refuse the access of these doctors to patients, since "they are endangering them..." The mainstream news outlets refuse to let them be heard, and their writings and videos often get taken down by social media networks and Google. On the other hand, doctors who work to push the vaccines are raised on high and are privileged to extensive media recognition.

28. **ARE YOU AWARE** that recently, even the mainstream media publicized **many cases of**

<sup>7</sup> There are tens of tried and proven treatment protocols. See below for examples:

1. Hydroxychloroquine (or its alternatives Ivermectin and Quercetin) together with zinc: This is a protocol which works to stop the multiplication of the virus in the body within the first week of infection. The effectiveness of this treatment for curing and preventing COVID was proven in 196 clinical studies with a success rate of 99.99%. (If the treatment begins within the second week of the virus, there is also a high rate of success.) Yet, if a person receives the vaccine, this protocol is unfortunately ineffective.

Note: Hydroxychloroquine exists on the market for more than 65 years, and was used by billions of people, of all types, ages, and in many situations, including millions who are taking it consistently for years. It has been proven to have less side-effects than Tylenol. (It is interesting to note that during the past year, some medical journals have printed articles claiming that Hydroxychloroquine can be dangerous. Yet, it was later revealed that these reports were fraudulent, and they were removed from the journals.)

2. High doses of Vitamins C and D: This protocol strengthens the immune system, which prevents most COVID symptoms. (Side-effects of COVID stem from an imbalance in the immune system). Indeed, Doctors in the U.S.A have conducted a study which analyzed the blood tests of patients with severe COVID symptoms. It was shown that none of the patients had a high vitamin D levels, and the lower the vitamin D level in the blood, the more severe was the illness.

severe blood-clotting in people after being vaccinated with the AstraZeneca and Johnson & Johnson Covid-19 vaccines? In many countries they stopped offering these vaccines to younger people, in Denmark they completely stopped the use of the AstraZeneca vaccine, and in the U.S., the J&J vaccine was put on hold for some time. Also, there was a leaked Israeli Ministry of Health probe which showed that there were concerns among experts regarding episodes of **heart inflammation amongst young people** who got the Pfizer vaccine, particularly between ages 18 and 30.

Even with all the advanced science we have, and with billions of dollars invested in development, there really is no way of assessing how the immune system might react to a foreign agent which enters the body. The only way to assess this is through long-term studies and there are none.

**29. Translation of a letter written by Harav Yosef Binyamin Wosner, Rosh Yeshivas Chachmei Lublin, Rav of the Zichron Meir neighborhood in Bnei Brak, and grandson of the Shevet Halevi:

**To the question of many in our community**

In light of the discussions and preparations to begin vaccinating also children age 12 and up, I bring before you in the shortest possible format the things which became more clear to me over the last few months [in addition to what we spoke Thursday night *Parshas Vayigash* of this year—Translator's note; it can be heard on *Kal Hachaim* 718-223-5535, press 1, 2 (in Yiddish)]—

After many long hours of collecting mass amounts of testimonies on vaccine-related injuries, and their positive and negative effects, whereas on the one hand, the [corona] disease has almost completely stopped and the authorities attribute this to the vaccines, and on the other hand, we are seeing all different types of side-effects [occurring] to men and women 'in all ages', whether in causing deaths, body injuries at varying levels of severity, and varying severe levels of psychological harm, *Hashem Yerachem*.

The above-mentioned testimonies were heard from the mouths of senior Doctors, veteran MDA and Hatzalah personnel, including a very long-time paramedic, while during 'all' the testimonies were also seated at the table known doctors who certainly 'recommend' the vaccines and were themselves vaccinated - alongside official protocols and data that were publicized by various Government ministries.

My conclusion is based solely on 'testimony' according to Torah law, obviously with the required evidence, and the required analyzing, although I did not take into account the predictions cited by various Doctors and studies both in *Eretz Yisrael* and the whole world, which foresee severe side effects in the future, may Hashem have mercy and watch over all of the house of Israel, rather everything is only based upon the facts that we have in the 'present'.

1. As per the classification of my grandfather zatzal in his *Sefer Shevet Halevi* [regarding the general definition of 'Me'ut Hamatzuy', we can conclude that], the categorization of damages resulting from this vaccine is one of 'Me'ut Hamatzuy' [a significant minority], which according to Halacha one is obligated to take into consideration. Therefore, under no circumstances and by any means should one coerce someone into getting the vaccine.
2. Those who had corona should be particularly careful to avoid getting the vaccine because the danger [of negative reactions] is more common *ch"v*.
3. According to the Torah, it is a total and severe Issur to agree [to], assist [in], or give the vaccine to children, and anyone who is capable of preventing this is obligated to do so because of '*Lo Saamod Al Dam Rayecha*' - 'Do not stand by on your brothers blood', and an abundance of *Zechusim* (merits) will be attributed to him.

And in conclusion we ask from everyone to increase in Tefillah and Tachanunim that Hakodosh Baruch Hu watch over the nation of Israel! from all trouble and sorrow, and from all plague and sickness, and may we merit to see in the salvation of Hashem and the raising of the glory of the Torah and Israel



## Is This a Possible COVID Vaccine Antidote?

name of it (which you can hear in this video excerpt): suramin. The disturbing horror stories of the COVID vaxxed never seem to end. Firstly, there are all the numerous adverse effects of those who have taken the COVID non-vaccine including migraines, bruising, miscarriages, potential sterility and potentially lethal blood clotting. (You can read what people are self-reporting at this Reddit group – scary). Then, there is the bizarre phenomenon of the COVID vaxxed transmitting these

effects to the unvaccinated just by being around them. On top of that, there is the phenomenon of magnets sticking to the COVID vaxxed at the injection site. The point of the COVID non-vaccine

is to program your RNA to make spike proteins so that your body will make antibodies against them, antibodies which will supposedly protect you against SARS-CoV-2. While there are many problems with this theory – including the fact there is no real SARS-CoV-2 and that spike proteins rest on the unfounded assumption of an isolated and purified virus – there is also the distinct danger that these artificially induced spike proteins will cause you harm. This is where the possible **COVID vaccine antidote** comes in.

### Possible COVID Vaccine Antidote: Suramin

Suramin is a drug which has been used as medicine for conditions such as African sleeping sickness and river blindness. It has been known to the medical profession for 100 years. Recently a small randomized clinical trial conducted by the University of California San Diego found that a single intravenous dose of suramin produced dramatic improvement of core symptoms of autism, aka autism spectrum disorder (ASD). So what is suramin exactly? It turns out that it's yet another pharmaceutical drug which is an extract of a natural substance, in this case pine needles. This follows the Big Pharma business model of **bio-piracy** – find natural plants and substances, isolate a chemical from them, get a patent on it and sell it, while using scientific journals and the media to trash anyone who claims the original plant has medicinal value.

The article *Possible Antidote for the V-Serum and the Current Spike Protein Contagion* does a good job of going down the rabbit hole to reveal what suramin does and where it comes from:

*“Here is the trail of science and data that shows the derivative relationship between pine needles and Suramin (“the elixir’s antidote” to microbial illnesses) – and which also provides a potential antidote for those affected by the spike protein contagion ... Suramin further decreases the activities of a large number of enzymes involved in DNA and RNA synthesis and modification: DNA polymerases (103, 104), RNA polymerases (103, 105, 106), reverse transcriptase (18, 103), telomerase (67), and enzymes involved in winding/ unwinding of DNA (107, 108) are inhibited by suramin, as well as histone- and chromatin modifying enzymes like chromobox proteins (109), methyltransferases (110), and sirtuin histone deacetylases (111). This is medical-speak for inhibiting the inappropriate replication and modification of RNA and DNA ... Suramin also showed*

*inhibitory effects against components of the coagulation cascade (71, 130) ... Excessive coagulation causes blood clots, mini-clots, strokes.*

Extremely interesting! It reveals that suramin inhibits **blood coagulation** or **blood clots** (a major theme throughout the entire **COVID op**) – the very issue that caused officials to be wary of the AstraZeneca and Johnson & Johnson COVID vaccines, causing many European nations to ban them, and also causing the US CDC at one point to halt them. Blood coagulation is also a theme of COVID itself, even before the advent of vaccines. What is also very fascinating is that suramin has the reported ability to decrease the activities of enzymes involved in DNA and RNA synthesis. This is exactly what the other 2 COVID vaccines – those made by Moderna and Pfizer – are trying to promote.

So, in plain English, this stuff could potentially slow or stop all the horrible blood clots people are suffering, plus potentially block the inappropriate RNA and DNA replication that the mRNA devices are trying to engender.

#### **Suramin is Derived from Pine Needles**

So where does suramin come from? Pine needles. It is one of many phytochemicals or plant chemicals that comes from pine needles, as the above article summarizes:

#### ***“Suramin is Derived from Trypan Blue***

*Trypan blue is derived from toluidine, that is, any of several isomeric bases, C H N , derived from toluene. Trypan blue

*is so-called because it can kill trypanosomes, the parasites that cause sleeping sickness. An analog of trypan blue, suramin, is used pharmacologically against trypanosomiasis. Trypan blue is also known as diamine blue and Niagara blue... Trypan red and trypan blue were first synthesized by the German scientist Paul Ehrlich in 1904.*

***Trypan Blue is a derivative of toluene which is a derivative of pine oil.***

*The compound was first isolated in 1837 through a distillation of pine oil by the Polish chemist Filip Walter, who named it rétinnaphte.”*

#### **Why Take Suramin when You Could Make and Take Pine Needle Tea?**

Why take a synthetic and isolated version when you could take the full-spectrum natural substance?

*“Pine needle tea provides a similar, if not superior, benefit, due in part to the fact that it is a direct mild extract of the whole herb leaving many of its properties still intact that might be destroyed by excessive heat during distillation and further dissection of its many nutrient components ... Pine needles are high in vitamin C and A among numerous other compounds which provide a long list of benefits:*

*A 2011 Korean study demonstrated using pine needles in tea was the best way to access the antioxidant benefits from pine needles. The study demonstrated that the hot water extract of pine needle proanthocyanidins and catechins offer the highest levels of antioxidant benefits compared with chemical extract processes. There are other known benefits that pine needle tea and the tea made from other conifers share, which include:*

## Final Thoughts

As always, do your own research. I am not claiming suramin and/or pine needle tea is **the** COVID vaccine antidote, but rather a possible COVID vaccine antidote. More research needs to be done. If you are going to make your own, make sure you research what you're doing – be careful with the yew pine (which is not a true pine and can be toxic, although it does have some medicinal properties). The cypress is not to be used as an essential oil in high doses, but normally safe otherwise. Overall, however, pine needle tea has amazing health benefits. Being aware of natural substances which can block **DNA and RNA replication** may be very important knowledge in the years to come as we face an increasing virulent **nanotech invasion** carried out under the rubric of Operation Coronavirus.
